1. Data Protection

1.1 I acknowledge and agree that:

- (a) information provided to the duly appointed officers of the Sarnia Sword Club and any of their duly authorised representatives (the “Administrators”) by me will be stored on the Administrators’ computer system and manually and may be stored on the personal computer system or in manual records of each of the Administrators.
- (b) For the purposes of the Data Protection (Bailiwick of Guernsey) Law, 2017 (the “Data Protection Law”) and other relevant data protection legislation which may be applicable, each of the Administrators is required to specify the purposes for which they will hold personal data. The Administrators will only use such information for the purposes set out below (collectively, the “Purposes”), being to:
 - (i) process my personal data (including sensitive personal data) as required by or in connection with my subscription and membership of the Sarnia Sword Club (the “Club”) including processing personal data in connection with competitions, leagues, coaching courses and social events or otherwise;
 - (ii) communicate with me as necessary in connection with my affairs and generally in connection with my membership of the Club;
 - (iii) provide personal data to such third parties as the Administrators may consider necessary in connection with my affairs and generally in connection with my membership of the Club or as the Data Protection Law may require, including to third parties outside the Bailiwick of Guernsey or the European Economic Area;
 - (iv) transfer personal data to other fencing clubs or the Guernsey Union d’Escrime LBG (GUE), British Fencing (“BF”) or the Federation Internationale D’Escrime (“FIE”) whether situated inside or outside the Bailiwick of Guernsey or the European Economic Area who wish to use such information for statistical, marketing, regulatory or competitive purposes or otherwise to promote, advise or communicate their services to me, including by means of electronic communications;
 - (v) process my personal data for the internal administration and good governance of the Club.

1.2 In providing the Administrators with information, I hereby consent to the Administrator holding and using my personal data for the Purposes above and I also represent and warrant to the Administrator that I have obtained the consent of any data subjects other than myself to the Administrator holding and using their personal data for the Purposes and that I will use my best endeavours to obtain the consent of the data subjects to the Administrators holding and using personal data for the processing of any personal data for the Purposes.

1.3 For the purposes of this Application Form, “data subject”, “personal data” and “sensitive personal data” shall have the meanings attributed to them in the Data Protection Law.

2. Risks and Disclaimer

- 2.1 I acknowledge, understand and agree that fencing is a martial sport involving the use of weapons which may and can cause injury or death and where other people will, as is the nature of the sport, attack me with the intention of hitting me.
- 2.2 The Club and any Administrators accept no liability in respect of any loss, damage, injury or death sustained from any cause whatsoever in respect of fencing or other related activities provided by the Club, the administration of the Club, or any competitions administered by the Club from time to time.

3. BF/GUE Membership

I acknowledge and agree that if I am not a member of the BF/GUE I will not have the protections afforded to me as a member of that organisation including the right to insurance cover in the event of my loss, injury or death or that suffered by others for which I may be found liable.
